ISSUE AND LISTING OF NEW UNITS UNDER THE DISTRIBUTION REINVESTMENT PLAN

11 September 2024 – Further to the announcements dated 25 July 2024, 2 August 2024, 12 August 2024 and 21 August 2024, Mapletree Industrial Trust Management Ltd., as manager (the “Manager”) of Mapletree Industrial Trust (“MIT”), wishes to announce that it will issue 7,447,147 new units in MIT (“Units”) at an issue price of S\$2.2209 per Unit pursuant to MIT’s distribution reinvestment plan (“DRP”) in respect of MIT’s distribution for the First Quarter Financial Year 2024/2025 from 1 April 2024 to 30 June 2024 (the “1QFY24/25 Distribution”) on 12 September 2024.

The new Units will be credited by 12 September 2024 to securities accounts of MIT unitholders (“Unitholders”) who have elected to participate in the DRP. The new Units will commence trading on the Main Board of Singapore Exchange Securities Trading Limited (“SGX-ST”) at 9.00 a.m. on 12 September 2024.

The new Units will rank *pari passu* in all respects with the existing Units.

Following the issuance of the new Units, the total number of MIT Units in issue has increased from 2,836,142,733 to 2,843,589,880.

Unitholders who did not elect or partially elected to participate in the DRP and overseas Unitholders who did not provide registered addresses in Singapore to The Central Depository (Pte) Limited, will receive their respective entitlements to the 1QFY24/25 Distribution in cash on 12 September 2024.
