### **COMPLETION OF DIVESTMENT OF FLEXHUB**

Further to its press release dated 10 November 2023 and the announcement dated 4 June 2024, Mapletree Logistics Trust Management Ltd., as Manager of Mapletree Logistics Trust ("MLT"), wishes to announce that the divestment of Flexhub in Malaysia has been completed today.

Following this divestment, MLT's portfolio stands at 186 properties, comprising 47 properties in Singapore, 14 in Australia, 43 in China, 9 in Hong Kong SAR, 3 in India, 24 in Japan, 13 in Malaysia, 21 in South Korea and 12 in Vietnam. The total value of assets under management is S\$13.3 billion<sup>1</sup>.
